



SCAMBLER TOWNSHIP BOARD MEETING MINUTES-APPROVED

TUESDAY, JUNE 15, 2021, 7:10 PM

Present: David Ritchie, Dennis Carlblom, Todd Langseth, Erick Johnson, Nance Hebert, Sandy Tingelstad, and Christie Shulstad.

The Board Meeting was called to order at 6:58 pm by Chairman David Ritchie with the Pledge of Allegiance.

The Board Meeting was held under CDC and MN Covid 19 guidelines for vaccinated and unvaccinated individuals. Guidelines were updated May 14, 2021.

Approval of the Agenda: Dennis Carlblom made a motion to approve the agenda. Nancy Hebert seconded the motion. Motion approved.

Clerk's Report Minutes: Minutes from the May 18, 2021 Board Meeting were presented. Motion by Dennis Carlblom to approve the minutes. The motion was seconded by Erick Johnson. Motion approved.

Treasurer's Report: Treasurer Christie Shulstad presented the financial report for May, 2021 and June claims for approval. Erick Johnson made a motion to approve the treasurer's report and claims. The motion was seconded by Dennis Carlblom. Motion approved. The checks for claims were signed.

Communications: No communications were received.

Zoning Report: No permits issued in May. Arvig inquired if a permit is needed to install cable in the township road right of ways. Discussion. No permit is required.

Road Report: Road Supervisor Dennis Carlblom reported dry road conditions due to lack of rain. The ditch mowing is complete. Dust guarding and crack sealing are also complete. The *NO PARKING* signs for South Pelican Drive have been ordered. The signs will take at least 45 days to receive. The township currently has a few signs and will be put on South Pelican Drive before the 4th of July weekend. Dust guard was applied on 460th St from US Hwy 59 to 205th Ave. The application was accidentally applied to all of 460th and should have been only from US Hwy 59 to South Sand Lake Road. Corbin Excavating brought two trucks to do the dust guarding and the driver of the second truck did not have a township rider in his vehicle to instruct him on turning on South Sand Lake Road and not applying the dust guard to all of 460th St. In the future, the township will provide riders to be in all trucks that will be applying dust guard to the township roads.

A township resident is requesting dust guard to be applied to 470th St from US Hwy 59 to North Sand Lake Road and on to North Sand Lake Road. The dust guard will be applied at the resident's expense.

Property Board Report: Property supervisor Erick Johnson reported the septic system was inspected by a plumber. There is no ground water seepage and the system looked good.

Hospital Board Report & Minutes: No report for the second month in a row. The township has not received minutes or financial statements since the February 22, 2021 hospital board meeting.



Old Business: No old business.

New Business: No new business.

The next Scambler Town Board meeting will be Tuesday, July 20, 2021 at 7pm.
