

SCAMBLER TOWNSHIP BOARD MEETING MINUTES-APPROVED

THURSDAY, MARCH 12, 2020, 7:00 PM

The Board Meeting was called to order at 7:01 pm by Chairman David Ritchie and opened with the Pledge of Allegiance
